Motion for Resolution 2011-12-20-01 A Resolution Accepting Transfer to the Township of Conway of Tax Reverted Parcel No. 4701-01-101-016 and 4701-01-101-020 From the Livingston County Treasurer.

WHEREAS, Public Act 123 of 1999, hereinafter sometimes referred to as the "Act", established an expedited process whereby property on which taxes have not been paid could be sold for unpaid taxes; and

WHEREAS, the Act creates a series of stages through which a property on which the taxes have not been paid must pass before that property can be sold; and

WHEREAS, the Act allowed each county in the State of Michigan to decide whether its treasurer or the State of Michigan would act as the governmental entity responsible for overseeing the stages through which a property on which the taxes have not been paid must pass before the property is sold; and

WHEREAS, the Act refers to the governmental entity responsible for overseeing the stages through which a property on which the taxes have not been paid must pass before the property is sold as the foreclosing governmental unit; and

WHEREAS, PURSUANT TO A CONCURRING RESOLTUION OF THE County Board of Commissioners, the Treasurer of Livingston, (hereinafter referred to as the "Treasurer"), is the foreclosing governmental unit under the Act with authority to take all actions judicial or otherwise, required under the Act in order to sell property on which taxes have not been paid in Livingston County; and

WHEREAS, one of the stages through which a property on which the taxes have not been paid must pass before the property is sold in foreclosure; and

WHEREAS, the Act proscribes how the Treasurer is to dispose of property obtained by foreclosure; and

WHEREAS, the Act requires that the Treasurer give a list to the Treasurer of Conway which shall list all the property in that township on which the Treasurer has foreclosed that has not been sold prior to November 1 of the year in which it is foreclosed upon; and

WHEREAS, the property for the current year is as follows:

Tax Parcel No. 4701-01-101-016 Tax Parcel No. 4701-01-101-020

WHEREAS, unless the Township of Conway objects in writing, the Act requires the Treasurer to transfer to the Township fee simple title to the property on that list; and

WHEREAS, the Township of Conway may, in the future, receive from the Treasurer a list of property that will be transferred to it if it does not object; and

WHEREAS, the Township of Conway does wish to obtain from the Treasurer the above described properties, namely parcel no. <u>4701 01 101 016</u> and <u>4701 01 101 020</u>.

NOW THEREFORE BE IT RESOLVED, that the Township of Conway wishes to obtain parcel no. 4701 01 101 016 and 4701 01 101 020, upon which the Treasurer has foreclosed this year, at an estimate cost of chargeback taxes in the amount of \$390.00 and therefore accepts transfer of such property from the Treasurer under the Act; and

BE IT FURTHER RESOLVED, that the Township of Conway authorizes the township clerk and township supervisor signatory authority to take ownership of parcel no. 4701 01 101 010 and 4701 01 101 020 on behalf of the Township of Conway.
