Successful contractor must provide proof of required insurance. Bids must be submitted on the form provided and shall be presented in a sealed envelope clearly marked "REQUEST FOR LAWN AND GROUNDS MAINTENANCE PROPOSALS". Fax or email copies will not be accepted. The Township reserves the right to waive all informalities in the bidding process and may reject any or all bids, in whole or in part, for reasons deemed to be in the best interest of the Township. The Township is requesting a one (1) year bid.

All bids shall be valid for 60 days beyond the due date.

# **SCOPE OF SERVICES:**

Please read all conditions and specifications. It is the bidder's responsibility to familiarize themselves with the locations where services are go be provided.

### 1. Routine Facility Maintenance

Blowing of clippings from walks and drives, blowing of leaves, removal of all trash and miscellaneous debris from each site (including along and under any fence lines) for each cutting, and maintenance of planting beds (if applicable) and fenced area behind hall. Cutting and site work per specifications shall be required weekly, weather permitting, and in no event shall intervals be longer than ten (10) days between any cuttings. Mowing season shall begin on April 1st or as soon as grass height exceeds 3 inches and shall continue to the end of October.

### 2. Clean Up

Additional clean up, including Spring Clean up, may be performed as per requested by Conway Township and a quote must be given upon request.

### **GUIDELINES FOR CEMETERIES**

Selected Contractor must take all necessary precautions to avoid damage to existing headstones. If the selected Contractor is concerned that any specification detailed in the RFP may cause damage to a headstone, please notify the Township prior to performing the work. The Township will work with the Contractor on a case-by-case basis to make any necessary adjustment to preserve the headstones. Please note that depending on the time of year, the grounds can be very soft. If the use of any machinery or equipment in the course of the work

causes any damage to the property, the Contractor will be responsible for repairs and restoration.

### **BIDDER QUALIFICATIONS:**

Bidder must be experienced in lawn and grounds maintenance and provide a minimum of three (3) commercial references (preferably municipalities) in which the project has comparable size and scope. Bidder must supply verification of the following insurance coverage at the stated amounts:

TYPE MINIMUM COVERAGE

Workers' Compensation: \$ 100,000 each accident

Property Damage: \$ 500,000 each occurrence

Bodily Injury: \$ 500,000 each occurrence

Personal Injury and Bodily Injury: \$1,000,000 each occurrence

Bidder must supply all personnel, equipment, supplies, insurance and materials to complete the scope of services and specifications.

# **SELECTION CRITERIA:**

### PAYMENT\INVOICES

Lump Sum:

Bidders shall present quotes on the enclosed form based upon a seasonal lump sum for each stated site. Breakdown by specification is required and a total must be shown. The lump sum includes the cost of all WEEKLY maintenance.

All lump sum work must be performed per the conditions stated above. Contractor is responsible to provide invoices for all items. Payments for lump sum portion will be made following an invoice for Contractor as follows: equal monthly payments May through November.

#### OTHER:

Any additional clean up of the five (5) cemeteries, work at the Township Hall and any other requested work are to be additional charges, if agreed to by both parties in writing They are NOT to be included in the lump sum. They must be invoiced only after completion.

## **HOURLY CHARGES:**

To be invoiced as incurred. All pre-approved requests from the contractor shall be in writing and shall include an estimate of the cost of materials, if any, together with the anticipated hours for the work and service performed. ## **NON-IRAN LINKED BUSINESS**

If Contractor or any employees of contractors of either directly or indirectly cause any damage to any such property, then Contractor at Contractor's expense will immediately repair, rebuild or otherwise restore the same or otherwise make whole such damage and notify the Township Supervisor in a manner reasonably acceptable to the Township and/or owner thereof.

## **TERMINATION:**

The Township may terminate this agreement, upon not less than 30 days written notice, to the Contractor, for the Township's convenience and without cause.
